Wetaskiwin Ski Club will provide lift operators, ski patrol and technicians for the duration of the rented period. Rental fee for the Gwynne Valley Ski Area is \$265.00 per hour; minimum 3 hours - \$795.00. Skis, ski boots, poles, helmets, snowboards and snowboard boots can also be rented from the Rental Shop at the attached rates. These rates are over and above the Rental Fee for the hill. The rental forms must be signed by a parent or guardian, if equipment renter is not 18 or over. If the renters would like the concession open, please let us know at the time you book the hill. The Wetaskiwin Ski Club is not responsible for the loss or theft of any personal belongings. Conditions of the hill rental are subject to air temperature, weather conditions on day of rental, and any other problem which may arise, that would be deemed as cancellable by the Wetaskiwin Ski Club. A booking deposit will be collected at time of hill reservation, in the amount of two hundred \$200 dollars.

### CANCELLATION GUIDELINES

Guidelines for cancellation: you have one week prior to date of rental to cancel booking due to lack of participation of group members. The Wetaskiwin Ski Club must be contacted one week (7 days) prior to booking date or booking deposit will be forfeited. If the hill is open for public use and you're not sure if the snow conditions are adequate, please contact us. We do not open the hill to the public if we don't feel it is safe to operate. If the hill needs to be closed down for any reason (ie: snow conditions, temperature, mechanical failure etc.) the "renters" will be contacted as soon as the decision has been made. The "RENTER" is advised to give out the Ski Hill's phone number (780-352-3515) so their members may call if unsure if the Hill is open or not.

If all the conditions are met after the hill has been rented, the two hundred dollars will be refunded to you within a couple of days. This money does not go toward the cost of the Hill rental fee.
